Through constant political engagement with its neighbours in a particularly tumultuous region, as well as through the promotion of trilateral projects in diverse areas such as energy, shipping, tourism, education etc with the active participation of the private sector, it seeks to promote a regional environment of collaboration, common interests and shared perspective on the future. Cyprus will continue to promote universal adherence and the full national implementation of the Rome Statute of the International Criminal Court, also in its capacity as co-focal point of the Assembly of States Parties of the ICC for achieving universality and full implementation of the Rome Statute. Cyprus will also continue to support and encourage other States to ratify the Agreement on Privileges and Immunities of the ICC (APIC) and the amendments to the Rome Statute adopted in Kampala which reinforce the Rome Statute system. <p>Cyprus will enhance its efforts to raise awareness and enhance effective international cooperation, in the framework of the UN, the Council of Europe, as well as other relevant international fora, on the important issue of the destruction of cultural heritage during armed conflicts, which constitutes an aggravating factor in armed conflict and may also present major obstacles to dialogue, peace and reconciliation. Cyprus commits to bringing forward a transformation of its own humanitarian system, by designing a National Humanitarian Policy Plan, which will review the follow up on the commitments expressed at the WHS and include 5 year strategic planning of Cyprus' humanitarian assistance. It will also ensure that organisational structures and internal processes foster coherence between humanitarian and development actors; allocate a minimum of 5% of humanitarian financing to unearmarked funding; allocate a minimum of 10% of humanitarian financing to supporting hosts in coping with large refugee caseloads; ensure that ODA increasingly contributes in reducing the risks of man-made and natural disasters by linking climate change with disaster risk reduction efforts. ## Core Commitments

### Political Leadership to Prevent and End Conflicts

#### POLITICAL LEADERSHIP TO PREVENT AND END CONFLICTS

- Commit to improve prevention and peaceful resolution capacities at the national, regional and international level improving the ability to work on multiple crises simultaneously.
- Commit to address root causes of conflict and work to reduce fragility by investing in the development of inclusive, peaceful societies.
- Commit to make successful conflict prevention visible by capturing, consolidating and sharing good practices and lessons learnt.

### Uphold the Norms that Safeguard Humanity

#### UPHOLD THE NORMS THAT SAFEGUARD HUMANITY

- Commit to promote and enhance respect for international humanitarian law, international human rights law, and refugee law, where applicable.
- Commit to promote and enhance the protection of civilians and civilian objects, especially in the conduct of hostilities, for instance by working to prevent civilian harm resulting from the use of wide-area explosive weapons in populated areas, and by sparing civilian infrastructure from military use in the conduct of military operations.
- Commit to ensure all populations in need receive rapid and unimpeded humanitarian assistance.
- Commit to promote and enhance efforts to respect and protect medical personnel, transports and facilities, as well as humanitarian relief personnel and assets against attacks, threats or other violent acts.
- Commit to speak out and systematically condemn serious violations of international humanitarian law and serious violations and abuses of international human rights law and to take concrete steps to ensure accountability of perpetrators when these acts amount to crimes under international law.

### Leave No One Behind

#### LEAVING NO ONE BEHIND - A COMMITMENT TO ADDRESS FORCED DISPLACEMENT

- Commit to collectively work towards a Global Compact on responsibility-sharing for refugees to safeguard the rights of refugees, while also effectively and predictably supporting States affected by such movements.

#### WOMEN AND GIRLS: CATALYZING ACTION TO ACHIEVE GENDER EQUALITY

- Ensure universal access to sexual and reproductive health and reproductive rights as agreed in accordance with the Programme of Action of the International Conference on Population and Development and the Beijing Platform for Action and the Outcome documents of their review conferences for all women and adolescent girls in crisis settings.
- Ensure that humanitarian programming is gender responsive.

### Change People's Lives: From Delivering Aid to Ending Need

#### NATURAL DISASTERS AND CLIMATE CHANGE: MANAGING RISKS & CRISES DIFFERENTLY

- ◻ Commit to accelerate the reduction of disaster and climate-related risks through the coherent implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030, the 2030 Agenda for Sustainable Development and the Paris Agreement on Climate Change, as well as other relevant strategies and programs of action, including the SIDS Accelerated Modalities of Action (SAMOA) Pathway.
- ◻ Commit to reinforce national and local leadership and capacities in managing disaster and climate-related risks through strengthened preparedness and predictable response and recovery arrangements.
- ◻ Commit to improve the understanding, anticipation and preparedness for disaster and climate-related risks by investing in data, analysis and early warning, and developing evidence-based decision-making processes that result in early action.
